4. **Date and place of opening of bids:** 19 January 2024 @ 10h00 at Namibian Correctional Service bid box, Central Depot Dr Michael De Kock Street, Northern Industrial Area, Windhoek.
5. **Number of bids received by closing date:** Seven (07).

8. Phase One: Mandatory Documents and Eligibility Criteria of the Construction of a New Piggery Farm at Evaristus Shikongo Correctional Facility
