- (e) Letter from receiver of revenue confirming period of residence
- (f) Certified copy of non-Namibian ID (if in possession of one)
- (g) Police Clearance Certificate of country of origin and Namibia (not older than six months)
- (h) Certified copy of Namibian ID Spouse born in Namibia
- (i) Passport copies of the applicant. (original passport needed for verification of copies)
- (j) Certified copy of applicant (s) Valid Permit e.g TRP, PRP, Work Permit and Domicile
- (k) Motivation letter from both (husband and wife) with the Commission of Oath
- (1) Couples should appear themselves before the officer
